Although it is not rare for a <i>muad</i> to gore, it is rare to find a <i>muad</i> in the Diaspora because the warning has to take place in a court made up of judges who received <i>semichah</i> in <i>Eretz Yisrael</i> .

Although judges of the Diaspora cannot force the defendant to pay the *knas* to the plaintiff, they can place him in *nidui* (ban) until he pays voluntarily or goes before judges who have real *semichah*. Once the defendant pays or goes before judges who have *semichah*, the *nidui* is lifted.
